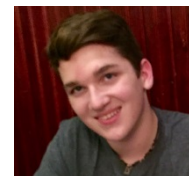


# Mykel Frank-Rothenburger Bursary Criteria



## Intent:

The intent of the Fund is to give an annual bursary of up to \$1000 to a graduating secondary school student who has challenges with Attention Deficit Hyperactivity Disorder (ADHD) or mental health. This student will be continuing their education in a post-secondary program at a College, University, trade school or similar institution. Financial need is a factor but not the sole determination.

## Application criteria:

- a. Applications must be submitted by May 1<sup>st</sup> to the BC Interior Community Foundation

- b. Applicants must reside in the area served by the British Columbia Interior Community Foundation (South Cariboo, Nicola and Thompson area). The applicant would be graduating from a school in School District #58, #73 or #74 or a Separate School in those regions.
- c. The applicant must submit two letters
  - i. One from a professional who can document the challenges the student has faced. This can be a teacher, counselor, doctor or anyone else who has worked closely with the student.
  - ii. The second letter must be from the applicant and provide a short biography, outline the challenges the student has overcome and give details of their plans for the future.
- d. While marks are not a primary consideration the applicant must submit them.
- e. The applicant must provide details of the program they will be enrolled in and proof they meet the requirements for that program
- f. Financial need is a factor and must be demonstrated but is not the sole determinant.

## Award:

- The annual award shall be up to \$1,000
